A regular meeting of the Darby Township Trustees was held Monday, April 7th, 2025 at 7:00 p.m. at the township meeting hall in Derby, Ohio. Present were the following trustees: Rob McNeal, Matt Corder and Chris Creamer. The minutes from the previous meeting were read. Mr. Corder moved to approve said minutes as read. Mr. Creamer seconded the motion. Chairman McNeal approved the minutes with his signature. In opening business, the trustees discussed constructing an addition to the salt storage building. The trustees also considered replacing the doors on the existing salt building. However, both matters were tabled for future consideration.

A preliminary draft of recommendations to modify the current zoning resolution was submitted. Colton Graham was in attendance regarding a certified letter he has received from the township zoning inspector concerning property clean up. This was in reference to property Mr. Graham owns within the village of Derby. A heated discussion followed regarding this matter. Mr. Graham has cleaned up the property to the satisfaction of the zoning inspector.

In other matters, Mr. Creamer moved to contract with GT Contracting LLC. To crack seal Renick Road and Drummond Road at an estimated cost of \$ 6700.00. Mr. Corder seconded the motion. A roll call vote followed: Mr. McNeal – yes; Mr. Corder – yes; Mr. Creamer – yes.

Mr. Creamer moved to pay the following bills with the fiscal officer certifying funds available. Mr. Corder seconded the motion.
